Other Terms and Conditions:-

1. Obligations of Dholak Master

Dholak Master is agreed to perform services at above place and time at above agreed price. In case of unavoidable circumstances i.e. accident, sick, death or other unavoidable reasons, if Dholak Master is not able to do performance, full refund of money will be refunded to the party.

II. Obligations of the Party:-

1. All payment in full (in balance after the advance payment) is due before start of program. The terms of payment are in cash or check. No credit card is acceptable.
2. The Dholak Master is only responsible to play the dhole for the time/hours written in agreement. After 30 minutes of above booked time, hourly rate (\$125/-) will apply for every hour spent after the agreed time of agreement. This will apply in all cases, including but not limited to, to delay in the start of function, weather conditions.
3. The performance of the Dholak Master outside the agreed upon time as listed above shall be at the sole discretion of the Dholak Master at the rate of compensation mentioned in 2 condition.
4. In the case of physical loss to Dholk Master, Team members, instruments, the party shall be liable for the full reimbursement to the Dholak Master.

III. Cancellations and Refund Policy:-

Full refund will be paid to the party/organization, if Dholak Master cancel program by giving prior three days notice to the party by email or phone from the date of function. No refund is due to party if the party cancel program within three business days of the performance date.

IV. Misc. Provisions:-

1. This agreement shall be construed and enforced in accordance with the laws of State of Michigan. In the event of an unresolved dispute, each party hereto consents and agrees that any litigation arising therefore shall be commenced and maintained exclusively in the state and federal court of competent jurisdiction located in the State of Michigan.
2. The Dholak Master reserves all rights to the performance. Unauthorized production, distribution of video, tape, CD's, pictures of performance is not permitted.
3. The provisions of this agreement shall bind and insure to the benefits of the parties hereto and their heirs, legal representatives, successors and assigners. This agreement constitutes the entire understanding between the parties hereto.
